01	Community level meeting	Nisha Kumari conducted a community-level meeting on 13 April 2022 in Rukanpura, Patna . Around 39 girls joined the meeting, which discussed gender equality, self-love, legal rights, and girls were made aware of how to register FIR and the right procedure to file it.

The girls were encouraged to contribute to the discussions and discussions. At the end of the session, the Eva Foundation gave the girls who had finished their individual computer courses in the Computer Centre their computer certifications and Savita Ali handed them certificates.

Rights of women include those to integrity and autonomy, to be free from sexual assault, to vote, to occupy public office, to equal rights in family property, to work and be paid equally, and to reproduce. The system for victim symbols is also in place, with each state government required to make restitution to the victim or his dependents who have suffered loss or damage as a result of the offence. The State or District Legalities Authority must compensate the victim or its dependents where the criminal cannot be located or recognized but the victim can be located and no trial is held. The camp was attended by social activists Ranju Kumari and Geeta Kumari, as well as panelists attorney Savita Ali and attorney Amir Subhani. The issues facing women were addressed with them, along with potential solutions, and further efforts should be done to improve the community.</p> <p>(Non- Budgeted)</p>

Anganwadi Sewika and Asha also played a significant role in the program's success. Despite the United Nations' theme Digital, only one girl in the entire village has enrolled in technical training. Rita Devi was a key factor in the success of the programme. (Non – Budgeted)

Community level meeting:

Date: 13th April 2022

Venue: Rukkanpura

Community level meeting was conducted by Ms. Nisha Kumari on 13th April 2022, at **Rukkanpura**. 39 girls joined the meeting. Community meeting was conducted by Ms. Shabeena Parveen, Ms. Puntti Kumari, and Ms. Nisha Kumari on 13th April 2022, at Rukkanpura. First, the program started with an introduction. Nisha Kumari gave the lecture on the topic of fundamental rights, she made them aware of their rights including the Right to Equality, the Right to freedom, the Right against exploitation, the Right to freedom of Religion, Cultural and Educational Rights, and Right to Constitutional Remedies and after that, some of the rights were discussed with the women. Some of them were unaware of their rights due to lack of knowledge, women who came there belonged to Dalits and minorities. Miss Nisha Kumari explained the Journey of Dr. B.R Ambedkar, struggles, and successes. We discussed with them the benefits of government schemes such as *Shauchaly Nirman Ghar ka samaan*, and *Betibachao Betipadhao*. The state government launched that yojna. The provision of a toilet in every house would be made to make Bihar, free of open defecation, healthy and clean, without any discrimination to all households of the state under this Nishchay. After that we discussed the student credit card, specially made for a resident of Bihar, age should be at least 25 years, and should be passed 12th standards. All these were the eligibility to take the advantage of these yojna. We end the program with Manav Shankala.

Capacity building training on Legal Rights:

Venue: Phulwari, Patna

Date: 11th October 2022

Eva Foundation conducted a comprehensive one-day capacity-building training program on leadership for young girls in Jaanipur. The aim of the program was to empower the participants with essential leadership skills and legal knowledge, enabling them to become effective leaders in their communities.

Adv. Savita Ali facilitated the program, providing a warm welcome to the participants and outlining the objectives and agenda of the training. An ice-breaking activity was conducted

to create a comfortable and inclusive environment, allowing the participants to introduce themselves and share their expectations from the training.

The training program focused on the goal of leadership. A unique art activity on goal setting provided a platform for the participants to visually represent their short-term and long-term aspirations. With the guidance of Arzoo Begum, the girls utilized thoughts to express their concerns and express their visions for personal and community development. This introspective exercise allowed them to explore various facets of their ambitions and contemplate the necessary steps to achieve them. Sharing their thoughts during the session fostered mutual inspiration and support among the participants.

Another crucial session was dedicated to First Information Report (FIR) writing, conducted by Aamir Subhani. The participants learned about the significance of providing accurate and detailed information when reporting crimes. Practical examples and case studies were utilized to illustrate the importance of specific details in an FIR. Active participation through discussions and question-and-answer sessions further enhanced the participants' understanding of the reporting process and the role of an FIR in the criminal justice system.

After lunch the training program began with an energizer activity to invigorate the participants. Adv Savita Ali recapped the key points covered on the previous day, reinforcing the concepts, and ensuring continuity in their learning journey. The central focus of the second half was an extensive session on leadership, where the participants delved into the essential qualities and attributes of effective leaders. They learned about different leadership styles and were equipped with practical tips and strategies for enhancing their leadership abilities.

Overall, the capacity-building training program provided a holistic learning experience for the young girls of Janipur. The combination of interactive sessions, art exercises, and informative discussions on FIR writing and leadership skills proved highly beneficial. The program not only enhanced their understanding of leadership but also fostered personal growth, confidence, and self-expression. The participants were equipped with the necessary tools and knowledge to explore the concept of leadership and become effective agents of change in their communities

Distribution of Computer Certificate and Career Counseling:

Date: 13th October 2022

Venue: Janipur, Phulwari block, Patna

Total Number Participants: 35 Girls

With the assistance of several experts, Eva Foundation organized career counselling exclusively for the girls of the hamlet Janipur in the Phulwari Block of the Patna District.

The counselling program has included more than 35 girls.

We are aware that choosing a course of study is one of the most important steps towards establishing a successful future. In particular, choosing a topic to study after matriculation is one of the most difficult decisions any student has ever had to make. Eva Foundation organized a one-day interaction session with the girls in the community in order to address these issues and improve education generally, with matriculated girls from the village as the target group. During the session, a number of questions were addressed by experts in order to help students.

Discussions have become more engaging and two-way thanks to the participation of girls.

Ranju, Shabina, Nisha, Puntti, and as a facilitator, I helped make this career counselling successful.

And at the end of the session, the Eva Foundation gave the girls who had finished their individual computer courses in the Computer Center their computer certifications.

Advocate Savita Ali handed the certificates, and her presence brightened up the entire meeting.

District Legal Services Authority, Eva Foundation, and community Meeting report (DSLAA):

Date:12/11/2022

Venue: Rukunpura Musahar Tola, Patna

Eva Foundation and District Legal Services Authority collaborated to host a one-day awareness program on women's rights in Rukunpura Musahar Tola, Patna. That camp Twenty or so women took part. The camp was put on by the Eva Foundation and the District Legal Services Authority, with help from the District Legal Services Authority's panel of

attorneys Savita Ali, Amir Subhani, Ranju Kumari, and Geeta Kumari. 1. To educate women on their legal rights.

2. Promoting understanding of the victim symbol scheme

3. Disseminating information about the District Legal Services Authority's free legal services.

Fourth, Basic Rights

1. Educating women about their legal rights Women's rights are those that are acknowledged as belonging to every woman and female child in every civilization on earth. Among the rights of women are those to integrity and autonomy, to be free from sexual assault, to vote, to occupy public office, to equal rights in family property, to work and be paid equally, and to reproduce. The right to education exists.

System for Victim Symbols 2.

(1) In cooperation with the federal government, each state government is required to make restitution to the victim or his dependents who have suffered loss or damage as a result of the offence. Additionally, each state government is required to develop a plan for allocating funds for those who need rehabilitation.

(2) The District Legal Services Authority or the State Legal Services Authority, as applicable, shall determine the amount of compensation to be paid under the plan referred to in subsection whenever the Court recommends compensation (1).

(3) If the trial court determines after the verdict that the damages granted under section 357 are insufficient for such rehabilitation or if the cases result in acquittals or dismissals. He could suggest compensation if the victim is to be rehabilitated and the victim is to be compensated.

(4) The State or District Legal Services Authority must compensate the victim or his dependents where the criminal cannot be located or recognized but the victim can be located and no trial is held. is qualified to apply.

(5) The State or District Legal Services Authority must conclude its investigation and provide reasonable compensation within two months of receiving such recommendations or applications under subsection (4).

(6) The State or District Legal Services Authority, depending on the circumstance, may, upon certification of a police officer not below the rank of in-charge of the police station or the Magistrate of the concerned area, provide first aid or medical facilities or make any other temporary adjustment to lessen the victim's suffering. may immediately impose whatever

remedies the authority deems appropriate necessary. As our company arrived at Musahar Tola, a group of ladies themselves, as well girls and women there. And as soon to communicate individuals, all the kids began to



appropriate necessary. As our Skhunpura Patna, we observed discussing among as another group of who were gambling as we all attempted with those girls, women, and depart from that

area. Nobody wanted to chat, but when we stopped them and said we did, a lot of ward members and non-government workers came over, engaged them in conversation, and then left. They also don't follow through on their promises, which makes them unwilling to communicate with outsiders. After much persuasion, he consented to speak, and the ladies and kids then shared their concerns about how their cousin had been apprehended by the police who had wrongly suspected him of being intoxicated when, in fact, he had not. Also, 12 women stated that they had not yet benefited from any government programs, including neither Indira A. nor Ayushman cards. Well, she used to attend school, but the instructor there ejected her from the institution. You have passed; there is no need to return to school, and the name was struck out. He said that he had not yet benefited from any government programs. He has a lot of difficulties in his day-to-day existence.

1. On behalf of attorneys Savita Ali and Amir Subhani, they were also informed about the advancement of women, their rights, and their fundamental rights in this camp. On behalf of Ranju and Geeta Kumari, they also spoke about education and government initiatives.

2. In the end, this camp's findings show that the Eva Foundation and the District Legal Services Authority collaborated to host a one-day special camp on women's rights. This camp had about 20 female participants. Social activists Ranju Kumari and Geeta Kumari attended the panel as well as panelists attorney Savita Ali and attorney Amir Subhani to educate women on their rights, the victim symbol programme, the District Legal Services Authority, and fundamental freedoms. Also, the issues facing women were addressed with them, along with potential solutions. It was also decided if further effort should be done to improve this community. in order to provide the community's women and girls an opportunity to advance.

District Legal Services Authority:

Date: 30th December

Venue: Koriyama, Phulwari Sharif

On behalf of the Eva Foundation and the District Legal Services Authority, Vyavahar Court arranged a one-day special camp on women's rights in Koriyama Phulwari Sharif Mushari Tola, Patna. Around 25 women and a few men attended. visited | On behalf of the Eva Foundation and the District Legal Services Authority, Vyavahar Court, field coordinator Punt Kumari and community mobilizer Nisha Kumari, social workers with the Eva Foundation, made contributions to this camp. This camp's goal was to educate women about their rights. As I got to Koriyama Mushari Tola, we noticed that some ladies were working there and in their own homes, while others were conversing in a group. And as soon as I wanted to talk to everyone, all the ladies, girls, and children left the area. Nevertheless, when I stopped them and engaged them in conversation, I discovered that many government employees or ward members had come to speak with them before departing. Because of this, none of the members desired to speak with us all. After much persuasion, he decided to speak, and the ladies and kids explained their situation: their family had been apprehended by the police, who had accused him of being intoxicated when, in reality, he was not. Also, he stated that no one has yet benefited from government programmes, including neither Indira Awas nor Ayushman Bharat. The girls said that while they had been admitted to the school and had previously attended it, their names had been blacklisted and they were no longer permitted to study there. and informed you that you had passed and were no longer required to

attend class. He claimed that despite his struggles in everyday life, he has yet to benefit from any government programs. Also addressed were the advancement of women, their rights, and fundamental freedoms. Nisha Kumari spoke on government initiatives and education.

District Legal Services Authority and the Eva Foundation Legal awareness camp:

Date: 27th February 2023

Venue: Janipur Patna

On February 27, 2023, from 12 p.m. to 2 p.m., the District Legal Services Authority and the Eva Foundation hosted a legal awareness camp. Puntti Kumari served as the event's main speaker, and the program was specifically designed for victims of the Eva Foundation and the District Legal Services Authority (Area Coordinator, Eva Foundation). There was a Program held at Janipur Patna. where more than 25 folks took part and shared their issues.

The processes of a criminal trial and victims' rights were reviewed, along with the practical challenges that victims confront, domestic abuse, and how government agencies carry out the law. Also, both presenters mentioned that if the



police filed your FIR. How to proceed and file a FIR against the police if it wasn't registered That will be noted. He also spoke about the FIR, the rules governing bail and bonds, and the victim compensation program.



Each person fully engaged in the event and asked the speaker a lot of questions. The participants appeared quite content and joyful. The program was effective, really helpful,

and educational. those who succeed in the event. Puntti Kumari one (Area Coordinator) Second Nisha Kumari Gupta (Community Motivators)

The program's principal outcome is that people who use violence will be aware of their legal rights and will resist it.

More than 50 female students interacted with them throughout the session. Also, they went online to the Sitamadhi sewing machine center.

India Fenwick, a finalist for Miss England, and Rakes Gatrar expressed their appreciation for the humanitarian work of the Eva Foundation during a presentation by Mr. Amir Subbhani, who also discussed other efforts including the Parwaz Women Network and the Bihar Legal Network.



Visitors from the UK talked with the victims who had had various problems.

India Fenwick also described their social project, called. With the primary goal of preserving the environment, they explained to students and Foundation members how single-use plastic damages the ecosystem and how the RRR concept—REDUCE, REUSE, and RECYCLE—is crucial for improving the environment.



India Fenwick described her journey and shared the tale of how she was born with the uncommon condition Microphthalmia, which caused the growing of her left eye to cease, and how she overcame many challenges to accomplish her objective. District Legal Services Authority (DSLA) And Eva Foundation Women's week Celebration:

Date: 10th March

Venue: Janipur, Phulwari Block, Patna

Total Number of Participant: 55

In honour of International Women's Day, Eva Foundation in collaborations with District Legal Services Authority (DSLA) held a Women's Week celebration in the village of Janipur in the Phulwari Block of the district of Patna. Anganwadi Sewika and Asha also played a significant role in the program's success.

During the presentation, Advocate Savita Ali discussed a number of important subjects, including human rights, the prohibition of domestic violence, the importance of job advancement for women, particularly girls, and the extremely productive issue of capacity development programmes. We know that Bihar is a dry state where alcohol consumption is strictly prohibited, but the administration, such as the police department, files false cases against the husbands of numerous women and Men of village as they don't even check whether the person has taken alcohol before they directly file false case, as they were very interested in making two-way communication during interaction.



Even the Panchayat, the village's local governing body, provides no assistance to the villagers. Additionally, there are several hygiene-related problems in the village that have an impact on the health of the local population. However, the most ironic aspect of this situation is that, despite the United Nations' introduction of the theme Digital: Innovation and Technology for Gender Equality for International Women's Day, only one girl in the entire village has enrolled in technical training.

Facilitator Shabina talked with the group, walked them down a road of technical knowledge, and introduced them to a number of government-sponsored programmes, including PMKVY, or Pradhanmantri Kaushal Vikash Yojana.
