

The holistic approach aimed not only to educate but also to evaluate the transformative impact on participants through pretest and post-session assessments. Forty girls actively engaged in this training, contributing to their empowerment and legal awareness.	
03	Network Advocates	The EVA Foundation organized district-level network advocate	
	meeting	meetings in Patna, Muzaffarpur, Sitamarhi, and Aurangabad, aiming to empower young advocates from marginalized communities, particularly Dalit, SC, and minority backgrounds. With 235 participants so far, the events signify a commitment to empowering marginalized advocates and fostering collaboration for justice and equality in Bihar. 05	Fact Finding	The Eva Foundation done 10 fact-finding missions on heinous cases including gang rape, POCSO violations, murder, mob lynching, and honour killings, focusing on marginalized communities such as Dalits, SCs, and minorities. These efforts aim to shed light on injustices faced by these communities, provide support to victims, and advocate for justice and accountability. By investigating these cases, the foundation seeks to bring attention to systemic issues and work towards creating safer and more equitable societies for all.
06	Emergency Case Support	The Eva Foundation provided emergency case support in 24 instances, recognizing the urgent need for assistance in times of crisis. Such support is crucial to ensure immediate access to legal aid, shelter, medical assistance, and other essential services for individuals facing emergencies. By swiftly addressing these situations, the foundation aims to alleviate suffering, protect rights, and prevent further harm. Emergency case support underscores the foundation's commitment to providing timely and effective assistance to those in dire need, contributing to the welfare and safety of the community.
07	Bail	The Eva Foundation facilitated bail for 45 individuals who were in need and unable to afford legal assistance. By securing bail for these needy and impoverished individuals, the foundation ensured access to justice and prevented unnecessary pretrial detention, which disproportionately affects marginalized communities. This initiative reflects the foundation's commitment to upholding the principle of equality before the law and providing support to those who are economically disadvantaged. Through these efforts, the foundation aims to safeguard the rights and dignity of all individuals, regardless of their financial status, fostering a more just and equitable society.
08	Case Trail	The Eva Foundation has successfully facilitated the trial of 52

cases. A case trial is a legal proceeding where evidence is

court of law. It's a crucial step in the justice system as it allows

applicable laws. Case trials are important as they provide a fair
and impartial forum for resolving disputes, holding wrongdoers
accountable, and delivering justice to victims. By supporting and
facilitating case trials, the Eva Foundation plays a vital role in
upholding the rule of law, protecting rights, and promoting
accountability within the community.

This centre offers access to a wealth of legal centre literature, providing a valuable resource for local advocates and interns to review and enhance their knowledge.

11. Mental health The Eva Foundation conducted mental health sessions facilitated by session seven trained mental health experts. These sessions were held in community schools and colleges, reaching a total of 536 participants. Mental health awareness is crucial for us as it promotes understanding, reduces stigma, and encourages early intervention. By providing this training, we empower individuals to recognize signs of mental distress, seek help when needed, and foster supportive communities.

Legal Awareness Camp

Eva Foundation, a non-governmental organization committed to promoting justice, equality, and empowerment, recently organized a series of Legal Awareness Camps across different districts and courts. The primary objective of these camps was to address the rising cases of atrocities against women, Dalits, Scheduled Castes (SC), and minorities. The camps aimed to educate individuals about their legal rights and responsibilities, focusing on aspects such as filing FIRs, awareness of fundamental rights, and combating domestic violence.

The primary goal of the Legal Awareness Camps was to empower individuals with knowledge about their legal rights. By fostering a deeper understanding of the legal framework, participants were better equipped to assert their rights in various situations. We conducted online and offline legal awareness camp which helped us to connect with the community and get volunteer from the community who are in touch with legal fellows for any kind of legal support required, Impact of online legal awareness webinar is that people and advocate from different districts i.e. **Patna, Muzaffarpur, Sitamarhi, Nalanda, Bihar sharif, Aurangabad** and Courts are calling to associate with BLN initiative.

Posts were viral from the social media channels and had positive impact of overall networking. Till now we have conducted 9 legal awareness camp in four districts **with 807 no**. of participants in future we conducted more no. of legal camp with more participant for the betterment of our communities.

Legal Awareness Camp Report

Introduction:

The Legal Awareness Camp, held on 24th February 2024 at DR. Bhim Rao Ambedkar Library in Chiraut Sitamarhi, was meticulously organized with a specific focus on empowering marginalized communities, including Dalits, SC, ST, and minorities. With approximately 100 participants in attendance, the camp served as a crucial platform to disseminate knowledge about fundamental rights and legal procedures. Led by our dedicated Legal officer, Mr. Mukesh Paswan, and supported by legal fellow Md. Faiyaz Bhatia, the camp aimed to equip individuals with the necessary tools to navigate the legal system effectively. The overarching goal was to foster a deeper understanding of legal rights among marginalized communities, thereby promoting greater empowerment and access to justice.



Objective:

The primary objective of this Legal Awareness Camp, specifically targeted towards empowering Dalit, SC, ST, and minority children and individuals, is to raise awareness about their fundamental rights. Through this camp, we aim to educate participants about the provisions outlined in various articles of the constitution that safeguard their rights. Our motive is to ensure that marginalized communities are equipped with the knowledge and understanding necessary to exercise their rights effectively, including the right to file a First Information Report (FIR) under appropriate circumstances.

About Session:



The Legal Awareness Camp commenced with Mr. Rajiv Kumar Paswan, the library in charge, welcoming participants on behalf of the Eva Foundation. He introduced Advocate Mukesh Paswan, emphasizing his expertise in legal matters. Advocate Mukesh Paswan then provided an introduction about himself and the motive behind organizing the camp, stressing the need for legal empowerment within the community. Acknowledging the diverse backgrounds of the participants, Advocate Mukesh Paswan initiated an interactive session by inviting individuals to introduce themselves, share their hobbies, and aspirations for the future. Despite the large turnout of approximately 100 people, many participants enthusiastically engaged in the activity. Advocate Mukesh Paswan outlined the program structure, dividing it into three sessions to cover various aspects of legal awareness comprehensively. Following this, he introduced the first session, focusing on fundamental rights, particularly addressing the challenges faced by marginalized communities such as SC, ST, Dalits, and minorities. He stressed the importance of understanding fundamental rights, citing DR. B.R. Ambedkar's legacy and ideology as pivotal in advocating for social justice and equality. This session aimed to equip participants with the knowledge to advocate for their rights effectively. During the interactive session, Advocate Mukesh Paswan engaged the participants by posing a question about the number of fundamental rights guaranteed by the Constitution. Several girls confidently responded with the correct answer: there are six fundamental rights enshrined in the Constitution of India. Advocate Paswan commended their knowledge and proceeded to provide a brief explanation about each of the six fundamental rights, emphasizing their significance in protecting the rights and liberties of citizens. He elaborated on the importance of each right, highlighting their role in promoting equality, justice, and freedom in society. By empowering the participants with knowledge about their fundamental rights, Advocate Paswan aimed to in still a deeper understanding of constitutional principles and encourage active participation in the legal and democratic processes.

Second and Last Session:

In the second session, Advocate Mukesh Paswan delved into the discussion about sections pivotal to women's rights, highlighting the significance of legal provisions such as 354 (A, B, C, D), 376, 420, and 498A. Special attention was given to elucidating the nuances of each section and their implications in safeguarding women's rights and combating gender-based violence. The goal of the

session was to with а understanding of entitlements and for avenues cases related to women. A of this session format, which participation Advocate facilitated discussions and questions and participants,

He elucidated the significance of FIR in documenting the details of a criminal offense and initiating the investigation process by law enforcement authorities. Advocate Paswan also provided practical guidance on how to draft an FIR, emphasizing the importance of including accurate and detailed information about the incident. He encouraged participants to voice any doubts or queries they may have regarding the FIR filing process, ensuring that they felt confident and empowered to take action in the event of a crime. By demystifying the FIR filing process and providing insights into sections relevant to women's rights, Advocate Mukesh Paswan aimed to empower participants with the knowledge and skills necessary to navigate legal procedures effectively and advocate for justice in cases of gender-based violence.

Outcome:

- Increased awareness about legal rights and procedures among participants.
- Empowered individuals to seek legal assistance when needed.
- Encouraged active participation in legal matters within the community.
- Strengthened trust in the legal system and promoted access to justice.

Feedback:

Feedback from participants was overwhelmingly positive, with many expressing gratitude for the opportunity to learn about their legal rights. Suggestions for future camps included more practical demonstrations and specialized sessions on specific legal issues. The constructive feedback provided will be instrumental in shaping future legal awareness initiatives, ensuring that they continue to meet the evolving needs of the community. The Eva Foundation is committed to incorporating these suggestions and further enhancing the effectiveness and impact of its programs in empowering marginalized communities through legal education and awareness.

The Legal Awareness Camp held at Dr. Bhim Rao Ambedkar Library in Chiraut Sitamarhi on 24th February 2024 proved to be a resounding success in its endeavours to empower marginalized communities with knowledge about their legal rights and procedures. Through insightful sessions led by Advocate Mukesh Paswan, participants gained a deeper understanding of fundamental rights, particularly those pertaining to marginalized groups and women. The interactive nature of the camp fostered engagement and active participation, enabling attendees to ask questions and voice their concerns. Legal Training of Youth Girls

Fundamental Rights, Women Rights, and Domestic Violence

14th December, 2023

One day Para- legal Training programme for the youth girls organised by the Eva Foundation in the Patna. On the date of December 14, 2023, a one-day para-legal training session was organized by the Eva Foundation with young girls from various villages in Patna district. The training was divided into five parts, with the first part concluding on December 14, 2023. Youth girls from Janipur, Sabarchak, Panaipur, Shrivar, Nagwa, and Murgiyachak actively participated, making a total of 20 girls involved. The primary objective of this legal training was to educate young girls about fundamental rights, particularly those related to women's rights. The training began with reading of Preamble of the constitution, read by Advocate Mukesh Paswan, a legal officer associated with the Eva Foundation. He explained the fundamental rights provided by the constitution, rights that are essential and cannot be violated by the state, known as fundamental rights. He further told that 6 fundamental rights to the young girls.

The six fundamental rights are:

- 1. Right to equality (Article 14–18)
- 2. Right to freedom (Article 19–22)
- 3. Right against exploitation (Article 23–24)
- *4. Right to freedom of religion (Article 25–28)*
- 5. Cultural and educational rights (Article 29–30)
- 6. Right to constitutional remedies (Article 32–35)

Young girls spoke openly on Right to Education Article 21A; they were told that Article 21A gives the right to free and compulsory education. The girls said that education has become very expensive these days and poor people are not able to provide good education to their children.

Advocate Savita Ali, trustee of the Eva Foundation and an advocate of the Patna High Court, led discussions on women's rights and domestic violence. The emphasis was on teaching the youth girls how to write complaints effectively. Savita Ali highlighted the prevalence of daily instances of abuse against women and the lack of awareness among women about their rights. She mentioned the challenges women face when filing cases at police stations. According to a recent NCRB report, cases of domestic violence have significantly increased during the COVID-19 pandemic. Many women in India remain unaware of these issues, and some who are aware continue to tolerate abuse to avoid breaking their homes. Domestic violence includes any form of abuse, whether physical, mental, sexual, economic, verbal, or emotional. Ali urged that enduring violence within the home is also a crime. The term domestic violence encompasses any woman who has faced mistreatment with her body, mind, emotions, language, or financial situation. The event aimed to empower youth, raise awareness about legal rights, and emphasize the importance of fundamental rights. The discussions shed light on the need for women to be informed about their rights and the legal recourse available to them.

Advocate Ibara Raja told them about the FIR, Ibrar Raja explained the details of FIR and FIR should contain the name of the applicant, complete address, details of the incident, time, date and name of the accused.

- ➤ Girls can know their rights through this legal training

PARA LEGAL TRAINING PROGRAM - PART II

First Part Highlights (14th Dec 2023):

The inaugural session on 14th Dec 2023 laid the foundation for empowering young girls by introducing key legal concepts and fostering a supportive learning environment. Advocates and experts provided insights into the legal landscape, setting the stage for the comprehensive training continuum

INTRODUCTION:

The second part of the Para Legal Training Program, conducted on 27/01/2024 at Hotel S.S. Exotica in Patna, builds on the success of the first part held on 14th Dec 2023. The program continues to empower 20 youth girls from various villages in Patna district, i.e. from Murgiyachak, Nagwa, Janipur, Sabarchak, Daryapur, Shorampur, Painapur and Shriwar with a focus on legal aspects such as POCSO, fundamental rights, FIR procedures, and relevant sections.

This holistic approach aims not only to impart knowledge but also to assess the transformative impact on participants. The program aimed to not only impart knowledge but also measure the impact through pre-test and post-session assessments. A total of 20 youth girls actively participated in this training.



Training Objectives:

In addition to deepening the understanding of legal frameworks, the program incorporated a comprehensive assessment strategy. The primary objectives were to empower participants with knowledge about POCSO, fundamental rights, FIR procedures, and sections, and to gauge the effectiveness of the training through pre-test and post-session evaluations.

Pre-Test and Post-Session Assessment:

To measure the impact of the training, participants were provided with pre-test and postsession forms containing five questions each. The questions aimed to assess their knowledge before and after the training, providing valuable insights into the effectiveness of the program.

Pre-Test Questions:

1.What is your understanding of the POCSO Act?
2.Can you briefly explain the process of filing an FIR?
3.Name one fundamental right that you are aware of.
4.What does IPC stand for, and can you name any section mentioned in the training?
5.How confident do you feel in navigating legal procedures before the session

Key Speakers:

1. Advocate Sanju Singh (Resource Person - Patna High Court):

Advocate Sanju Singh, a distinguished legal expert from the Patna High Court, initiated the session by warmly welcoming and introducing herself to all the girls. To foster a sense of inclusivity, she encouraged each participant to share a brief introduction. The focus of the session was the Protection of Children from Sexual Offences (POCSO) Act. Adv. Sanju Singh commenced with a comprehensive discussion on the POCSO Act, delving into the nuances of sexual assault on both girls and boys. She clarified the definition of a child and outlined the age parameters specified under the act. Utilizing a visually impactful PowerPoint presentation, she presented a video depicting instances of child harassment and assault.

The necessity for the POCSO Act and its features were highlighted, with an emphasis on the offenses it addresses. Different categories of offenses, such as penetrative sexual assault,

aggravated penetrative sexual assault, and sexual assault, were explained, accompanied by the corresponding punishments. The discussion also touched upon the cognizable nature of these offenses, making them arrestable without a warrant, and the non-bailable status. Adv. Sanju Singh shared a compelling real-life story to underscore the importance of the POCSO Act in protecting children. In the context of the COVID-19 pandemic, she addressed the rise in telephonic and cybercrimes related to sexual harassment.



The session shed light on the role of the Special Juvenile Police Unit (SJPU) in handling cases under the POCSO Act. Adv. Sanju Singh explained the reporting process to SJPU and detailed the critical role they play. She elaborated on the medical care and examination procedures, emphasizing the importance of recording evidence to meet medical expenses and aid in rehabilitation. In addition, the roles of the Child Welfare Committee (CWC) and District Child Protection Unit (DCPU) were discussed. The session also explored the role of parents in supporting and understanding victims of child sexual abuse. Adv. Sanju Singh engaged the participants in a thought-provoking task, prompting them to write hypothetical

situations involving sexual harassment. The task aimed to sensitize the participants to potential real-life scenarios without disclosing their identities.

The session concluded with Adv. Sanju Singh expressing gratitude for the active participation and openness of the participants. The impactful stories shared during the session served to underscore the significance of creating awareness about the POCSO Act. Participants left the session with heightened knowledge, empathy, and a strengthened commitment to advocate for justice

2. Savita Ali (Managing Trustee, Eva Foundation, and Patna High Court Advocate):

Savita Ali's commenced by introducing herself to everyone, creating an atmosphere of familiarity and approachability. To gauge the participants' understanding, she asked questions related to the previous session, aiming to assess their grasp on the key concepts



discussed earlier.

The focus of Savita Ali's session was on First Information Reports (FIRs). She initiated a brief yet comprehensive discussion on FIRs, elucidating the process of filing and writing an FIR. Covering various sections, she explained the application of specific sections such as 376 for rape, 498A for marital cruelty, and 304B for dowry-related offenses. She acknowledged the dynamic nature of legal systems, hinting at changes in sections that

would be addressed in subsequent training sessions. The hierarchical structure of police stations was also discussed, providing clarity on the organizational setup. The session delved into the ethical dimensions of understanding legal rights, emphasizing why it is crucial for the participants. Savita Ali conveyed the importance of being aware of legal sections, linking it to the ethical responsibility one holds within society. Special attention was given to sections pivotal to women's rights, including 354 (A, B, C, D), 376, and 420, 498A with the goal of equipping participants with a thorough understanding of their legal entitlements and the available avenues for seeking justice. A distinctive aspect of this session was its interactive format, which encouraged active participation from the attendees. By presenting real-life scenarios, participants were encouraged to identify the relevant constitutional sections applicable to each case, thereby promoting a deeper understanding of legal provisions and their practical implications. Following the discussion, she actively engaged with the participants by posing questions about their preferences and learnings from the session. This interactive element aimed to reinforce key takeaways and ensure that the participants were actively processing and internalizing the information. The session not only provided valuable insights into FIRs and legal sections but also encouraged active participation and reflection among the participants. The overarching goal was to empower participants with knowledge about their legal rights, especially in contexts pertaining to gender equality and women's safety. This approach not only enhanced their awareness but also encouraged them to actively advocate for their rights. The dynamic approach adopted in the session, combined with Savita Ali's expertise, contributed to an enriching learning experience for all.

3. Advocate Mukesh Paswan (Legal Officer, Eva Foundation):

Advocate Mukesh Paswan conducted the final session on fundamental rights, initiating the discussion by prompting the participants to share their existing knowledge on the subject. Many participants shared their insights, leading to an interactive exchange.

Не proceeded to provide а comprehensive overview of fundamental rights, addressing the question of what rights entail. fundamental Mukesh Paswan highlighted the existence of six fundamental rights in our constitution, namely the Right to Equality, Right to Freedom, right against Exploitation, Right to Freedom of Religion, Cultural and Educational Rights, and the Right to Constitutional Remedies.



The necessity of understanding fundamental rights was emphasized, and Mukesh Paswan delved into a brief yet insightful description of the Right to Equality. He underscored the prevalence of caste discrimination in various societal contexts, making it imperative for individuals to be well-informed about their rights.

Encouraging an open dialogue, he invited questions and queries from the participants regarding the content he covered. With gratitude, Mukesh Paswan concluded the session, ensuring that the participants departed with a deeper understanding of fundamental rights and their significance in our constitutional framework.

Open Discussion-

In the open discussion, participants engaged in a comprehensive dialogue on key legal terms and provisions. The discourse began with a focus on the acronym POCSO, with participants elucidating that it stands for the "Protection of Children from Sexual Offences Act." Emphasis was placed on the primary objective of POCSO, which is to safeguard children from sexual abuse and exploitation through a robust legal framework. Subsequently, attention shifted to the procedural aspects of filing an FIR (First Information Report), with a participant clarifying that individuals need to visit the nearest police station and provide detailed information about the criminal offense to initiate an investigation. The discourse seamlessly transitioned into a brief overview of Fundamental Rights, described as the basic rights and freedoms guaranteed to every citizen by the constitution. Participants then delved into the specifics of legal sections, elucidating that Section 498A pertains to cruelty towards a wife in the context of dowry, while Section 304A deals with causing death by negligence.

The key speaker skilfully summarized the discussion, ensuring that participants had a comprehensive understanding of POCSO, emphasizing its role in protecting children from sexual offenses. The open dialogue fostered a collaborative environment, allowing participants to share knowledge and address any lingering queries. The engagement concluded with the key speaker prompting further questions, demonstrating a commitment to

continued learning and clarity on legal concepts. This insightful discussion served as a valuable exchange of information, contributing to a more profound understanding of legal frameworks and their practical applications. Talking openly helped us understand things better. Now we feel more confident about legal stuff they understand. This interactive exchange further enhanced the overall success of the training program.

Post-Session Questions:

- 1. Describe any new insights you gained about the POCSO Act.
- 2. Explain the steps involved in filing an FIR, as per the training.
- 3. List two fundamental rights you learned about during the session.
- 4. Share any specific section of the IPC that was discussed in detail.
- 5. Reflect on your confidence level in navigating legal procedures after the session.

Preliminary Observations:

The pre-test and post-session assessments will be analysed comprehensively in the coming weeks to provide a detailed report on the effectiveness of the training. Preliminary observations suggest positive shifts in participants' knowledge and confidence levels.

Beneficial Points:

- 1. Empowering Knowledge:
- The program equips participants with practical legal knowledge, enabling them to navigate the legal system confidently.
- 2. Promoting Advocacy:
- By fostering an understanding of legal rights, the training encourages participants to advocate for justice and address societal issues.
- 3. Enhanced Confidence:
- The interactive and participatory sessions contribute to a significant increase in participants' confidence levels, both in understanding legal concepts and navigating legal procedures.
- 4. Continued Learning:
- Participants express a desire for future training sessions, indicating a sustained interest in continuous learning and empowerment.

Conclusion:

The Para Legal Training Program, comprising both Part I and Part II, stands as a transformative initiative empowering young girls with legal knowledge and fostering a sense of advocacy. Open discussions played a vital role in clarifying doubts and ensuring participants left with a clearer understanding of legal matters. The holistic approach and ongoing support networks ensure that the program continues to be a catalyst for positive change, making it a beneficial and invaluable experience for all participants.

NETWORK ADVOCATE MEETING

Bihar Legal Network (BLN) is a network of lawyers and socio-legal professionals, to provide free legal support to marginalized and vulnerable sections of the society. In the wake of continuous violations rights of communities especially minorities and Dalits, Eva Foundation Patna has initiated a project "Bihar Legal Network" on dated 1st February 2021, with a mission to build a society where every aggrieved person has access to justice through fair and affordable legal services.

EVA Foundation, successfully organized a district-level network advocate meeting on Patna, Muzaffarpur, Sitamarhi, Aurangabad on different date in District Court. This meeting sought to realize the vision of empowering young emerging advocates from marginalized communities, specifically focusing on individuals from Dalit, SC and minority backgrounds. On the topic POCSO, POSH and Atrocity Act. Two-day residential training session 25-26th November 2023 held in the Navjotes Niketan, Near Kurji More, Patna.

DAY -1

The State level orientation programs start on 25th November, 2023 at 9:30 a.m. with the registration process and the participants registered his/her self.

Mr. Ibrar Raza and Makeshwar Rawat Welcomed all the guests and participants and introduced the topic. They introduced Savita Ali and Prita Jha and handed over the stage to the speakers. All participants, Advocates, paralegals, and support persons, introduced his/her self to everyone with details of their area of practice, district of practice, and challenges they face in society.

Introduction: Savita Ali Introduced the Collaborating organization objective, aim and purpose. The Capacity Building programme organizes by the Samegra Seva, Peace and Equality Cell- Ahmadabad, BAL Sathi, Bihar Legal Network and Eva Foundation. Representatives of Samegra Seva are Makeshwar Rawat, Prita Jha from PEC and Savita Ali from Eva Foundation. Savita Ali told how rights are being violated in the society due to lack of knowledge of rights. We all have together become the eyes and ears of the law and create confidence in the society. We all are meeting today with the intention that in two days of training we will all share our experience and try to understand all aspects of the POCSO, POSH and Atrocity law. She also stated that the two day training session is divided in two part, 1st part 25/11/2023 on CSA, POCSO and POSH taken by the Prita Jha and 2nd part 26/11/2023 on Sc/St Atrocity Act taken by the Savita Ali and Mukesh Paswan.

1. Prita Jha from the Peace and Equality (PEC), asked to share their experiences as to what they know about CSA and POCSO. Prita Jha forms 6 team and in each team 11 members, all the team present their views on CSA and POCSO. Adv. Azad and his team told that CSA is child sexual abuse, an attempt is made to sexually abuse children by luring them and some people also do wrong in this. This is related to sexual crime. He also stated that POCSO stand for Protection of Children from Sexual Offence Act, This law is related to sexual harassment of minor children. Prita Jha discussed CSA and POCSO through power point presentation. Child Sexual Abuse nowadays increasing rapidly in the society. In some cases, the victim does not say anything to anyone and keeps it hidden, due to which many times it becomes a very serious problem. Anyone can commit sexual abuse with children, we all should come together and talk about it openly with the society and all other people. She discussed different situation through the case study and ask some questions from the participants. All the participants participated and answered all the questions. It was a very good session. Prita Jha started POCSO session; tell everyone its purpose and objectives. Children are the future of India and got protection under various laws implicitly or explicitly. The Protection of Children from Sexual Offences Act, 2012 (POCSO) is enacted with the main objective of protection of children from various kinds of sexual abuses and offences. Before POCSO Act, 2012, the cases of child sexual abuse were dealt with under the sections of the Indian Penal Code, 1860. POCSO Act, 2012 was enacted when the cases of sexual abuse against children were rising. It contains provisions regarding the protection of children from sexual assault and pornography and lays down the procedure for the implementation of these laws. Incidents of sexual abuse against children occur at schools, religious places, parks, hostels, etc and the security of children is not guaranteed anywhere. With such emerging dangers, it was significant to introduce separate legislation which could provide a reliable system for mitigating the number of such offences and punishing the perpetrators.

Prita Jha discussed some of the salient features of the POCSO Act are discussed as follows:

- Confidentiality of the victim's identity:
- Gender neutral provisions
- Mandatory reporting of child abuse cases
- The last seen Theory
- Child Friendly investigation and Trial The following points are taken into consideration while investigating any crime under POCSO Act:

i. The statement of the child is to be recorded at his/ her place of residence and generally by a woman police officer.

ii. The officer who is to record the statement of the child should not be wearing a uniform.iii. The officer should ensure that the child does not come in contact with the accused during the examination.

iv. A child is not to be detained in the police station at night.

v. The officer should ensure that the identity of the child is not revealed.

vi. The statement of the child is to be recorded in the presence of a person in whom the child has trust, for example, their parents.

vii. The statement of the child is to be recorded via audio-video electronic means.

viii. The assistance of the translators or interpreters should be taken wherever necessary.

ix. Frequent breaks are to be allowed during the trial.

x. The special court has to ensure that the child is not called to repeatedly testify in the trial court.

xi. Aggressive questioning of the child is not permitted during the trial.

Savita Ali gave the Schedule Cast and Tribe Atrocity Act background; she started its objective and how the law was formed. She said that Articles 15, 16 and 17 of the Constitution state that there should be no discrimination on grounds of caste. Prohibition of discrimination on grounds of religion, race, caste, sex or place of birth.

Furthermore, our commitment to justice extends to the appellate level, as evidenced by our provision of free legal aid to atrocity cases in the esteemed Patna High Court. Despite the inherent challenges, we have successfully proposed support for 5 cases during the reporting period, culminating in the accomplishment of 1 case. This achievement underscores our unwavering dedication to upholding the principles of justice, equity, and human rights, even in the face of daunting legal obstacles.

In sum, the Eva Foundation's Legal Aid Initiative stands as a beacon of hope for those who have endured unimaginable atrocities, offering them the support and resources they need to pursue justice and reclaim their dignity. Our tireless efforts in providing essential legal aid exemplify our commitment to standing in solidarity with the most vulnerable members of society and ensuring that their voices are heard in the hallowed halls

Legal Resource Centre

A legal resource centre was recently established to support young lawyers belonging to marginalized backgrounds and those who are first-generation legal professionals. The primary aim of this centre is to provide essential resources and a conducive environment for these lawyers to enhance their professional capabilities. It offers access to crucial tools such as workspaces, legal documents, drafting materials, and research resources, including Bare Acts and Commentaries/Books covering diverse legal subjects. Given its recent establishment, the centre is being strategically utilized for various purposes. Plans are underway to utilize it for the training and education of young lawyers. Internship opportunities are being extended to law students from law schools in the Patna district. Additionally, efforts are Eva Foundation 10 directed towards establishing the centre as a hub for legal discussions, facilitating critical conversations among groups of lawyers on recent legal updates and judgments. Recognizing a prevalent lack of drafting skills among many young and marginalized community advocates, the centre aims to address this gap. Scheduled sessions led by senior network advocates are being planned every week to train and enhance the drafting skills of these aspiring lawyers. Overall, this recently established legal resource centre serves as a pivotal platform for not only providing resources and workspace but also for nurturing the professional growth and skill development of young and marginalized lawyers through training, discussions, and focused skill-building sessions.
